6.0 UNFINISHED BUSINESS

6.1 DISCUSSION OF REFINANCING THE DISTRICT'S CALPERS SIDE FUND OBLIGATIONS

Business Manager Malmlund reported that a recommendation regarding the refinancing of the district's CalPERS side fund obligations has been deferred until CalPERS announces their decision on the potential reduction of their investment discount rate, which is currently 7.75%. The establishment of a new lower interest rate could result in a revised amortization of the remaining side fund balance resulting in a lower required payoff amount. In addition, there are other critical factors to consider:

- 1. We have learned that the side fund obligations are peculiar in that there are no gains or losses recorded on the obligation. If the district ends up paying more or less than is scheduled for a year (as a result of a larger or smaller payroll than is projected by CalPERS) the variance is closed into the pool rather than carried over into the district side fund balance.
- 2. CalPERS assumes an annual 3.25% pay raise factor in their payroll projections and uses payroll data that is two or three old which is then factored up to create a next-year projection.

- 3. The district is currently experiencing payroll savings, compared to the CalPERS payroll projection, due to, a) Increased employee retirements which has and will continue to result in payroll savings due to step grade regression, and b) No pay raises having been recently awarded or currently being projected.
- 4. It appears the district's required 16.9% contribution rate on payroll next year will result in a side fund payment to CalPERS which is approximately \$50,000 less than the scheduled \$751,437 payment, with no penalty or loss carry forward to the district.
- 5. Lastly, it appears that the bulk of any potential savings resulting from a refinancing would occur in the last years of the remaining six year amortization with a potential increase in net cost to the district in the first years. There is some risk that changes over the remaining six year period could jeopardize the expected savings while scheduled refinancing debt payments would be fixed.
